Consider/Action to approve Ordinance #2016-06 adopting the proposed 2016-2017 City of Riesel Operating Budget (THIS BUDGET WILL RAISE MORE TOTAL PROPERTY TAXES THAN LAST YEAR'S BUDGET BY \$11,126 OR 5.99%, AND OF THAT AMOUNT, \$1,699 IS TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE ROLL THIS YEAR)

Consider/Action to approve Ordinance #2016-07 setting and levying a city tax rate to fund the 2016-2017 Operating Budget (current tax rate is .373515 and the new proposed tax rate is set at the rollback rate of .335416, which consists of an I&S Debt Rate of .083773 and an M&O Rate of .251643 for Maintenance & Operations)
05. Consider/Action regarding the approval of Subdivision Plat for Jena Place Addition submitted by Ross Miller Homes, LLC [Land described in Official Public Records of McLennan County, Texas in deed filed at Clerk's File #2015023987]
