NOTICE IS HEREBY GIVEN that the City Council of the City of Riesel, McLennan County, Texas, will hold a **SPECIAL** called meeting on Tuesday, **April 7th, 2015 at 6:30pm** at Riesel City Hall, 104 N Hwy 6, to discuss the following matters:

- 1) **Visitor's Comments:** This is an opportunity for visitors to bring any item to the City Council's attention. Comments limited to 3 minutes per visitor. No deliberation may be held on the matter, except limited to a proposal to put the subject on the agenda for a subsequent meeting.
- 2) **Consider/Action** regarding submitting a plan of action for arsenic treatment to TCEQ for the Rattlesnake Well. (presentation by Alan Draper, KSA Engineers)
- 3) **Discussion** pertaining to proposal from RMS WSC to negotiate contract minimum water usage from 500,000 gallons per month to 1,500,000 gallons per month and also increasing the rate by 25%
- 4) **Discussion** pertaining to a letter from Oakley's regarding additional parking for possible restaurant
- 5) **Discussion** pertaining to seeking an inter-local agreement with McLennan County to maintain Roadrunner Road & Kattner Lane
- 6) **Discussion** regarding park trees, landscaping & dedication
- 7) **Discussion** pertaining to city cleanup day on April 18th, 2015
- 8) **Discussion** pertaining to Free Fill Dirt on Adams Street
- 9) **Discussion** pertaining to sewer easement issue on Hwy 6 & Charles Street
- 10) **Discussion** pertaining to new home construction on Morris Street
- 11) **Consider/Action** regarding replat for Methodist Church Parsonage
- 12) **Discussion** pertaining to replat for Alvin Neuman on West Frederick and extending city water line to the new home
- 13) **Mayor's Report:** communication of information received from other government entities, update on educational materials received or continuing education opportunities, update on matters that mayor was directed to review by Council at a prior meeting, and identification of items which the Mayor desires to be placed on a future agenda
- 14) **Utility Department Report:** update on street projects, budget, needs of department, and identification of future projects to be brought back before the Council. Update on Water & Sewer operations, repairs, budget, department needs, water use, water forecasts, drought contingencies, conservation programs, government compliance, and ongoing projects.
- 15) **City Secretary's Report:** Financial/Budget Report, communications from the state or from state agencies, report on procedures being undertaken to bid or obtain quotes on previously authorized purchases of goods or services, and identification of items that the City Secretary believes should be considered by the Council for placement on a future agenda.
- 16) **Police Department Report:** update on activity of department for prior month, department budget, and needs of the department.
- 17) **Discussion** and possible directives to staff on data compilations, research, ordinances, regulations or policies that the members of the Council desire to be compiled or drafted for review by the Council at a subsequent meeting.
- 18) **Discussion** and possible action on ordinance violations and ordinance enforcement, including regarding weed and rubbish regulations, substandard building regulations, animal regulations, and health and safety regulations
