

Ordinance #2009- 06

AN ORDINANCE CERTIFYING THE ELECTION RESULTS FOR THE OFFICE OF MAYOR AND FOR THREE COUNCIL MEMBERS FOR THE CITY OF RIESEL, TEXAS HELD ON MAY 9, 2009 AND ORDAINING OTHER PROVISIONS RELATING TO THE SUBJECT MATTER THEREOF

WHEREAS, on May 9, 2009 an election was held in the City of Riesel, McLennan County, Texas for the offices of Mayor and three Council Members.

Section 1. After canvassing the returns of said election pursuant to the Ordinance of the City of Riesel and pursuant to the applicable provisions of the Texas Election Code, the City of Riesel Council certifies the following are true and correct results,

To wit:

1. Mayor: Dave Ross received 122 votes.
2. City Council Member: Katherine Bode received 102 votes; Gerry Suttle received 63 votes; Deena Tobias received 59 votes; Bobby Dieterich received 49 votes; Al Bumelis received 45 votes; Denise Krumnow received 40 votes; and Heath Laughlin received 35 votes.

Said election was duly called; that notice of said election was given in accordance with the law; and that the canvas of the votes cast in said election and returns thereof were made in accordance with the law.

Pursuant to the Ordinance of the City of Riesel and applicable provisions of the Texas Election Code:

1. Mayor: Dave Ross, having received a majority of votes cast, is hereby certified to be elected Mayor of the City of Riesel and shall commence his term of office upon the adoption of this Ordinance and the swearing to the oath as required by law.
2. City Council: Katherine Bode, Gerry Suttle, and Deena Tobias having received a majority of votes cast, are hereby certified to be elected to the City Council of the City of Riesel and shall commence his term of office upon the adoption of this Ordinance and the swearing to the oath as required by law.

Section 2. If any part or parts of this Ordinance are found to be invalid or unconstitutional by a court having competent jurisdiction, the such invalidly or unconstitutionality shall not affect the remaining parts hereof and such remaining parts shall remain in full force and effect, and that extend this Ordinance is considered severable.


