ADOPTING BUDGET FOR FISCAL YEAR 2006-2007**

WHEREAS, the City Council of the City of Riesel, Texas has considered a proposed budget for the municipal government of the City of Riesel, Texas for the fiscal year 2006-2007; and

WHEREAS, a public hearing was held on the proposed budget after notice of the same was given as required by law; and

WHEREAS, the City Council, after hearing the public on the issue and considering the said proposed budget, believes that the same should be adopted.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RIESEL, TEXAS:



ORDINANCE NO. 2006-10

AN ORDINANCE SETTING PROPERTY TAX RATE FOR 2006 FOR THE USE AND SUPPORT OF THE MUNICIPAL GOVERNMENT OF THE CITY OF RIESEL, TEXAS, DESIGNATING PURPOSES FOR SUCH RATE, FINDING AND DETERMINING THAT THE MEETING AT WHICH THIS ORDINANCE IS PASSED AND ADOPTED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW, ONE PUBLIC HEARING CONDUCTED ON SEPTEMBER 6, 2006, NOTICE OF THE PUBLIC HEARING PUBLISHED AUGUST 18, 2006


WHEREAS, the City of Riesel, Texas is empowered by the Texas Constitution and the Texas Property, Tax Code to establish a property tax rate for the use and support of the municipal government; and

WHEREAS, it is the desire of the City Council of the City of Riesel to set a property tax rate for the City for calendar year 2006;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RIESEL, TEXAS:

1. That the above recitals are true and correct.
2. It is officially found and determined that the meeting at which this Ordinance is passed is open to the public as required by law, and that notice of the time, place, and subject of such meeting has been given as required by law.
3. That there is hereby set and adopted a property tax rate for calendar year 2006 for the use and support of the municipal government of the City of Riesel, Texas, upon all property, real, personal and mixed, within the corporate limits of the City of Riesel subject to taxation, a tax rate of \$0.2500 on each \$100 valuation of property, said tax rate being so set and designated for the maintenance and operation expenditures of the City, one-half of the amount collected be deposited into the City's general fund and one-half of the amount collected be deposited to the City's water fund and then to be used in accordance with the budget adopted by this City Council for the City's fiscal year from October 1, 2006, and ending September 30, 2007.
