## ORDINANCE NO. 2006-06

AN ORDIANCE CERTIFYING THE ELCTION RESULTS FOR THE OFFICE OF MAYOR; AND FOR TWO CITY COUNCIL PERSONS FOR THE CITY OF RIESEL, TEXAS HELD IN THE CITY OF RIESEL, MCLENNAN COUNTY, TEXAS ON MAY 13, 2006 AND ORDAINING OTHER PROVISIONS RELATING TO THE SUBJECT MATTER THEREOF

**WHEREAS,** on May 13, 2006, an election was held in the City of Riesel, McLennan County, Texas for the offices of Mayor and two City Council persons.

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RIESEL THAT:

**SECTION I:** After canvassing the returns of said election pursuant to the ordinance of the City of Riesel and pursuant to the applicable provisions of the Texas Election Code, the City Council certifies the following are true and correct results,

To wit:

- 1. Mayor: That David Guenat, Jr. received <u>78</u> votes; Gerry Suttle received <u>69</u> votes.
- 2. City Council Person: Johnny Glen Skinner received <u>59</u> votes; Rodney Dieterich received <u>75</u> votes; Al Bumelis received <u>96</u> votes; Write-In Vicki Lynn Shaw received <u>59</u> votes.

Said election was duly called; that notice of said election was given in accordance with the law; and that the canvas of the votes cast in said election and returns thereof were made in accordance with the law.

Pursuant to the ordinance of the City of Riesel and applicable provisions of the Texas Election Code:

- 1. Mayor: DAVID GUENAT, JR., having received a majority of votes cast, is hereby certified to be elected Mayor of the City of Riesel and shall commence his term of office upon the adoption of this Ordinance and the swearing to the oaths as required by law.
- 2. <u>City Council (At Large)</u>: AL BUMELIS and RODNEY DIETRICH each having received a majority of the votes cast is herby certified to be elected to the City Council of the City of Riesel and shall commence his term of office upon adoption of this Ordinance and the swearing to the oaths a required by law.

**SECTION II.:** If any part or parts of this Ordinance are found to be invalid or unconstitutional by a court having competent jurisdiction, the such invalidly or unconstitutionality shall not affect the remaining parts hereof and such remaining parts shall remain in full force and effect, and to that extend this Ordinance is considered severable.

**CONSIDERED, PASSED and APPROVED** this 6<sup>th</sup> day of June, at a Council meeting of the City of Riesel, at which a quorum was present and which was held in accordance with Chapter 551, Texas Government Code.
