

## Ordinance 2005-14

**AN ORDINANCE LEVYING PROPERTY TAXES FOR 2005 FOR THE USE AND SUPPORT OF THE MUNICIPAL GOVERNMENT OF THE CITY OF RIESEL, TEXAS, DESIGNATING PURPOSES FOR SUCH LEVY, AND FINDING AND DETERMINING THAT THE MEETING AT WHICH THIS ORDINANCE IS PASSED AND ADOPTED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW, TWO PUBLIC HEARINGS CONDUCTED ON AUGUST 2, 2005, AND SEPTEMBER 6, 2005, NOTICES OF THE PUBLIC HEARING PUBLISHED AUGUST 26, 2005, AND JULY 22, 2005, AND POSTED ON THE CITY'S WEB SITE AS REQUIRED BY LAW**

**WHEREAS**, the City of Riesel, Texas is empowered by the Texas Constitution and the Texas Property Tax Code to levy, assess and collect property taxes for the use and support of the municipal government; and

**WHEREAS**, it is the desire of the City Council of the City of Riesel to levy a property tax for the City for calendar year 2005 at the rates previously set by Ordinance;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RIESEL, TEXAS:**

1. That the above recitals are true and correct.
2. That there is hereby levied and there shall be collected a tax for calendar year 2005 for the use and support of the municipal government of the City of Riesel, Texas, upon all property, real, personal and mixed, within the corporate limits of the City of Riesel subject to taxation, a tax of \$0.2500 on each \$100 valuation of property as set in Ordinance No. 2005-13, said tax being so levied and apportioned to the maintenance and operation expenditures of the City, one-half of the amount to be deposited into the City's general fund and one-half of the amount to be deposited to the City's water fund and then to be used in accordance with the budget adopted by this City Council for the City's Fiscal Year from October 1, 2005, and ending September 30, 2006.
3. The taxes levied under this Ordinance shall become due as provided in the Texas Property Tax Code, and if not paid on or before January 31, 2006, shall immediately become delinquent.
4. All taxes shall become a lien upon the property which is assessed hereunder, and the City hereby designates the McLennan County Tax Assessor-Collector to assess and collect taxes on behalf of the City and to be hereby authorized and empowered to enforce the collection of such taxes according to the Constitution

and laws of the State of Texas and all Ordinances of the City of Riesel, Texas, including this Ordinance.

5. All receipts by the City not specifically appropriated by the Ordinance shall be made as specified in above Section 2.
6. All monies collected under this Ordinance shall be for the specific items named above in Section 2, and the same are hereby appropriated and set apart for the specific purposes named above in Section 2.
7. It is officially found and determined that the meeting at which this Ordinance is passed is open to the public as required by law, and that notice of the time, place and subject of such meeting has been given as required by law.
