AN ORDINANCE ADOPTING AN AMENDMENT TO ORDINANCE NO. 96 SETTING FEES AND AUTHORIZING THE WACO- MCLENNAN COUNTY PUBLIC HEALTH DISTRICT TO COLLECT AND RETAIN THOSE FEES

WHEREAS, on August 4, 1984 the City of Waco and McLennan County entered into a Cooperative Agreement to continue the administration of a local public health program through the Waco-McLennan County Public Health District, and

WHEREAS, the City of Riesel has participated in a cooperative program pursuant to an agreement for the administration of certain health and welfare functions by the Waco-McLennan County Public Health District within the City of Riesel; and

WHEREAS, from time to time the fees adopted for Waco-McLennan County Public Health District services have been amended: and

WHEREAS, an amendment of the fees has been proposed by the Waco-McLennan County Public Health District for the upcoming fiscal year.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RIESEL, TEXAS that:

- 1. Section I of Ordinance No. 96 is amended to incorporate the new proposed fees as shown on Exhibit "A" hereto, which is incorporated by reference herein; and to replace the existing Exhibit "A" 'with the Exhibit "A" which is attached hereto.
- 2. Ordinance No. 96 otherwise remains in full force and effect, and unchanged by this Amendment.
- This Ordinance was adopted by the City Council of the City of Riesel, Texas at a 3. meeting properly posted and held in accordance with the Texas Open Meetings Act.
