Ordinance #2008 - 08

AN ORDINANCE CERTIFYING THE ELECTION RESULTS FOR THE OFFICE OF MAYOR AND FOR TWO COUNCIL MEMBERS FOR THE CITY OF RIESEL, TEXAS HELD ON MAY 10, 2008 AND ORDAINING OTHER PROVISIONS RELATING TO THE SUBJECT MATTER THEREOF

WHEREAS, on May 10, 2008 an election was held in the City of Riesel, McLennan County, Texas for the offices of Mayor and to Council Members.

Section 1. After cancassing the returns of said election pursuant to the Ordinance of the City of Riesel and pursuant to the applicable provisions of the Texas Election Code, the City of Riesel Council certifies the following are true and correct results,

To wit:

- Mayor: David Guenat, Jr. received 121 votes; Al Bumelis received 71 votes.
- 2. City Council Member: Gary Bennett received 143 votes; Jeff Tanner received 100 votes; Don Port received 32 votes; Rodney Dieterich received 100 votes.

Said election was duly called; that notice of said election was given in accordance with the law; and that the canvas of the voes cast in said election and returns thereof were made in accordance with the law.

Pursuant to the Ordinance of the City of Riesel and applicable provisions of the Texas Election Code:

- 1. <u>Mayor</u>: David Guenat, Jr., having received a majority of votes cast, is hereby certified to be elected Mayor of the City of Riesel and shall commence his term of office upon the adoption of this Ordinance and the swearing to the oath as required by law.
- 2. <u>City Council</u>: Gary Bennett, having received a majority of votes cast, is hereby certified to be elected to the City Council of the City of Riesel and shall commence his term of office upon the adoption of this Ordinance and the swearing to the oath as required by law.
- 3. <u>City Council</u>: Jeff Tanner and Rodney Dieterich having received an equal number of votes cast, are hereby scheduled to have a Run-Off Election. Said Run-Off Election is ordered to be held on the 14th day of June, 2008.

Section 2. If any part or parts of this Ordinance are found to be invalid or unconstitutional by a court having competent jurisdiction, the such invalidly or unconstitutionality shall not affect the remaining parts hereof and such remaining parts shall remain in full force and effect, and that extend this Ordinance is considered severable.
